This date and all other dates stated in these rules may be extended at the absolute discretion of SWIRCA & More. Tickets may sell out before the sales deadline. The winning ticket will be drawn at random from a hopper containing numbers of all eligible raffle tickets by a SWIRCA & More employee.
