

IDENTIFICATION

Travel within USA

For travel completed by May 2, 2023, all airlines will ask for identification when you check in. It is recommended that you carry a passport if you have one. A driver's license (with a photo I.D.) is also acceptable for domestic flights.

Effective for travel May 3, 2023 forward, the REAL ID Act standards for identification while travelling will be in effect. This means a standard issued driver's license used as a form of identification will no longer be accepted for domestic air travel within the United States. Instead, a Real ID compliant form of identification must be presented both at the time of booking air travel with Collette and upon checking in at the airport to board any flight. Any fees associated with changing a reservation resulting from a non-compliant identification will be the responsibility of the guest. IDENTIFICATION

Passports are required for this tour at your expense. Certain countries require a minimum of 6 months passport validity from date of return home. IMPORTANT: We recommend that our clients traveling abroad take a photocopy of their passport and applicable visas. It should be packed separately from your actual

passport and visa. We also recommend leaving a copy at home with your emergency contact.

Port taxes and fees starting from \$656 USD, quoted at time of printing, per guest are not included in the land only tour cost. Single cabins, if confirmed, are higher.

Some attractions may not be available during the off-season months. This is reflected in the price of your tour.

Order of ports may be changed by the cruise line.

Cruise ships have a limited quantity of cabins available in each cabin category. We will make every effort to accommodate your cabin category preference at the time of booking. **The Tundra Wilderness tour is a fully narrated 7-9-hour tour, including frequent rest stops. During the off season, this tour will be substituted with a shorter 4-hour tour due to inclement weather.

*Accommodations in Fairbanks will be assigned prior to departure.

The overall activity level of this tour is a level 1. This means you're a leisurely traveler. You like to discover the energy of a new place, but typically take it easy. You can handle at least one flight of stairs, board a coach, and walk for 15-30 minutes at a time with little difficulty.

Prior to full payment for the program, the cruise line reserves the right to impose a supplemental fuel charge. Should this occur, you will be notified of the additional charges.


